In addition, the Ontario Nurses Association provides all healthcare professionals with a reliable contract. This contract is set in place to highlight the rights and responsibilities of employees along with the employer. Contracts not only provide protection for violation of rights, but also any safety or health risks. In 2015 alone, ONA recorded approximately six thousand grievances on behalf of their members for reasonsons varying from discipline to smaller issues such as scheduling. Lastly, but arguably the most important, the Ontario Nurses Association provides a shield of protection to its members. The association prioritizes protection from things such as discrimination and harassment, as well as various types of health and safety hazards in the workplace. ONA has fought for many of its members, however the most memorable by far is those regarding Bill 124. For those who may be unfamiliar with Bill 124, it is a wage-suppression legislation that is negatively impacting all nurses, and healthcare workers that was introduced by the Ford government. This legislation essentially limits wage increases to a maximum of one percent total compensation for each of three years. ONA recognized how unfair this was to nurses and healthcare workers across Ontario, especially due to the pandemic causing even more distress in healthcare settings. The pandemic pushed many nurses and healthcare professionals to breaking point, and having Bill 124 in place was extremely unfair. The Ontario Nurses Association took initiative to fight for the rights of these well deserving healthcare professionals and took the Ford Government to court. The court found that Bill 124 was unconstitutional and a violation to the Canadian Charter of Rights and Freedoms. ONA mentions that the two main arguments they provided included how Bill 124 interfered with the association's right to freely collectively bargain, as well as the discrimination to a profoundly female dominant trade. Therefore, the Ontario Nurses Association is incredibly important as it has proven to fight for the rights and protections of nurses and healthcare workers throughout Ontario regardless of how large the issue like those of Bill 124.

In conclusion, the Ontario Nurses Association is important to nurses, and healthcare professionals because it improves their quality of work-life, provides a contract regarding their workplace rights, and lastly provides protection to its members. The Ontario Nurses Association improves the quality of worklife for its members by sharing common goals, and ultimately fighting for what healthcare professionals need to provide good quality care to the public.
