Thank you for completing the online Have Your Say bargaining survey, which we have reviewed, including your hospital-sector bargaining priorities. There are more than 1,100 pages of comments in this survey, and we have read each one. The comments have many similar and consistent themes, which we will address in bargaining.

The team, supported by negotiations staff, identified member priorities from the Have Your Say bargaining survey, reviewed the current realities in the hospital sector, the current state of health care, the threat to our public health-care system, and the realities we find ourselves practicing in. The team also engaged in planning mobilizing activities for all to get involved in.

For the first time in our provincial hospitals bargaining history, ONA members will have the opportunity to advise the team of their demands for this upcoming round of bargaining. This will happen through several demand-setting meetings. This process is a major shift for us, and we are excited to move full steam ahead with this initiative. Please note the following virtual demand setting meeting dates:

- Region 1 June 4, 2024 (1:00-4:00 ET)
- Region 2 June 4, 2024 (9:00-12:00 ET)
- Region 3 June 3, 2024 (1:00-4:00 ET)
- Region 4 June 3, 2024 (9:00-12:00 ET)
- Region 5 June 6, 2024 (1:00-4:00 ET)

If you did not receive a registration email, please register at <u>Hospital members – Helpus set demands for bargaining! – Ontario Nurses' Association (ona.org)</u>.

The team will convene again in September to begin the process of developing proposals based on members' feedback from these demand-setting meetings and the Have Your Say bargaining survey. Once this work is completed, there will be a meeting where the team will share the demands with membership and ask you to vote on the initial package.

We will be communicating on our progress and upcoming Hospital Contract Action Team (HCAT) mobilizing meetings for members related to bargaining through email, social media and on ONA's website at https://www.ona.org/hpnt.

We have set the following dates for negotiations with the Participating Hospitals: January 13-17, 2025 and January 27-28, 2025. The Memorandum of Conditions for Joint Bargaining will be sent to you when it is signed.

If we are unable to resolve the issues at bargaining, the Participating Hospitals and ONA have agreed to mediate any outstanding issues. Mediation will take place from January 29-30, 2025. If a settlement is not achieved during bargaining or mediation, two dates in April 2025 will be confirmed for arbitration.

To assist the HPNT in communicating to ONA members on our progress, we ask Bargaining Unit Presidents to add HPNT updates to your meeting agendas, post them on your worksite bulletin boards, Local website and/or social media, and provide hard copies where members do not have access to ONA's website.
